Minutes of the IQAC meeting held on 8th APRIL 2019

The first meeting of the reconstituted IQAC of the C.E.S. College was held on 8th April 2019 at Principal's cabin at 12.30 p.m. onwards to discuss the following agenda.

Agenda 1. Confirmation (compliance) of minutes of last meeting

Chairman, IQAC, Principal Dr. Sanjay P. Sawant Dessai, welcomed the members.

The minutes of meeting held on 8th April 2019 were read by Dr. A. A. Marathe, coordinator, IQAC and after discussion were confirmed unanimously by all members.

Agenda 2. Implementation of CBCS at V and VI SEMESTER from 2019-20,

For smooth implementation of CBCS Course in a phased manner during the academic year 2019-20 for the V and VI semester the requirements and feasibility plan were discussed. It included teaching plan, distribution of workload, separate description of Honors course for Commerce and General course for Arts. The core—and elective subjects were selected with reference to the nature and capacity of the third year students. The project papers at sixth semester and its effect on workload was also referred. The members suggested that a continuous effort and plan through IQAC meetings can be made to share other requirements, issues related for effective implementation of CBCS during 2019-20.

Agenda 3. Prospectus 2019-20,

It was decided that the prospectus should be made ready by third week of April as the admissions begin soon after the results of 12th standard during second week of April. The other requirements with reference to the procedures for online admission and availability were also noted. It was decided that the complete implementation and description plan of CBCS with necessary academic program, fee structure, institutional plan and the documents required for admission should be reflected in the

Prospectus of the year 2019-20 to benefit the students.

Agenda 4. Initiation of NAAC CYCLE 3,

The Principal of CES' College Dr. Sanjay Sawant proposed that Dr. Marathe will continue as the IQAC Coordinator. The IQAC team was reconstituted with new members from faculty, significant domain as Governing Council, Entrepreneurs. Parents, Alumni and student's representatives as per revised NAAC guidelines. It was proposed that a presentation of the new AQAR Manual for Affiliated colleges, effective from July 2017 needs to be conducted during the last week of April. As a way forward of IQAC, to meet the requirements of NAAC CYCLE III was initiated. All seven criteria committees were constituted and distribution of responsibilities according to the criteria and weightage was done. All members commonly assented for the acceptance of the responsibilities.

Agenda 4. A.O.B. It was recommended that a meeting of all members of reconstituted IQAC to be conveyed during the academic year 2019-20.
