Documentary on Road Safety was held on 18th December, 2020.


The Unit screened a documentary on Road Safety.

The Unit initiated spreading road safety awareness through shared videos. The response was overwhelming with the participation of 395 students.


Awareness on HIV/AIDS through Tree of Life (RRC)

Recovery of Indian economy after the pandemic

The economic of the COVID-19 pandemic in india has been largely disruptive. India's growth in the fourth quarter of the fiscal year 2020 went down to 3.1% according to the ministry of statistics. The chief economic adviser to the government of India said that this drop is mainly due to the coronavirus pandemic effect on the Indian economy. Notably India had also been witnessing a pre-pandemic slowdown, and according to the World Bank, the current pandemic has "magnified pre-existing risks to indies economic outlook."

The World Bank and rating agencies had initially revised Indies growth for FY2021 with the lowest figures Indies has seen in three decades since India's economic package in mid- May, India's GDP estimating were downgraded even more too negative figures, signaling a deep recession. On 26 may, CRISIL announced that this will perhaps be India's worst recession since independence. State bank of India research estimates a contraction of over 40% in the GDP inQ1. The contraction will not be uniform, rather it will differ according to various parameters such as sate and sector. On 1 September

2020, the ministry of statistics released the GDP figures for Q1 fy21, which showed a contraction of 24% as compared to the same period the year before.

"Silver lining of a deadly pandemic"- this sounds like an oxymoron, but its true when it comes to COVID-19. Even through the COVID-19 pandemic has wreaked havoc around the world and brought the world economy to a near standstill.

People face lots of impact during COVID-19 pandemic Since people have staying home, all types of travel also come to a halt, virtually eliminating the smoke generated by countless vehicles on the streets of the world, not to mention those contributed by airplanes, trains and other means of transportation. These factors have caused carbon dioxide and nitrogen dioxide emissions to fall drastically, making the air around the globe, particularly metropolitan cities just a bit cleaner and the skies, a bit bluer.

To enforce social distancing, businesses where people gather have been forced to close. The entertainment industry consisting of movies theaters, sporting events, concerts etc.is reeling under these constraints. Another sector that has been affected gravely is the service industry including restaurants, beauty salons, spas, barber shops etc.

Stock markets have crashed and plenty of large and small business have had to file for bankruptcies because they were unable to stay afloat and pay their bills without any income. However, the real face of the economic impact of the COVID-19 lockdown is not that of large companies going bankrupt, that of millions of daily wages labors and low income people who are out of work. Without any income during the lockdown, they have no way of feeding their families or keeping a roof over their heads.

Most governments have enacted rules temporarily preventing tenants from being evicted for not paying rents during the pandemic, but few have offered rent forgiveness. Even if the laborers are willing to risk their lives and go to work, the constraints imposed by government lockdowns make this nearly impossible and employment opportunities are next to none.

How are poor laborers who were constantly struggling to make enough money for one month's rent going to find the means to pay the back rent that is piling up, when they do not even have a job? Many economists predict increased unemployment, homelessness and bankruptcies in the months following the COVID-19 pandemic, leading to a global recession that could last years.

Usually, when one country faces a problem like a natural disaster, help will pour in form around the globe. But now, all countries are struggling with the COVID-19 pandemic and hence, help from abroad might be limited but there is one aspect in the world where it's having a positive impact-"the environment."

Through these signs of nature healing during the COVID-19 lockdown may give us hope that this could be a sustainable change, experts predict that such an outcome seems highly unlikely. Once the pandemic is over and the lockdowns are lifted, vehicles will start rolling, factories will come to life again, and the pollutants will cloud the air, just as it did before the lockdown.

Some experts even suggest that people may shirk public transportation in favor of private conveyances like cars to reduce the risk of being infected, thus leading to more vehicles on the streets post lockdown, causing more air pollution.

Nature has been the big winner during the COVID-19 pandemic. While human interference has been paused for the past few months, Mother Nature has reclaimed a bit of what humans took from her. Oil refineries and factories that spew venomous smoke into the atmosphere have been shut down.

Even though the positive effect the lockdown has had on the environment may not last long, it is still eye- opening to see how humans have exploited nature and the way mother nature tries to heal when humans leave her alone for some times . Hopefully, world leaders, environmentalists and policy makers have seen the uplifting visuals of nature regeneration during the lockdown and will try to take stronger steps to protect the environment in the future.

The role of mass media during the pandemic:-

Coronavirus disease 2019 (COVID-19) pandemic has produced a global health crisis that had a deep on the way we perceive our world and everyday lives. Not only the rate of contagion and patterns of transmission endangered our sense of security, but the safety measures put in place to contain the spared of the virus also required social distancing by refraining from doing what is inherently human, which is to find comfort in the company of others. Within this context of physical threat, social and physical distancing, the role of the different mass media channels and social media in lives on individual, social and societal levels cannot be underestimated.

They are loaded with world responsibility and it's not only entertaining the audience but also providing with relevant and genuine data. During lockdown the distribution of print media like newspaper and magazines have gone down. People fear and don't want to risk any possible transmission of virus

I can say that mass media is playing a very important role in the dissemination of the COVID-19 related information to the general public. However, the misleading or wrong information shall be checked in the large public interest. The ND government has set a target to make India a US\$ 5 trillion economy by 2025. The Indian economy would need to explain at a 9% CAGR to achieve this target, this currently looks difficult given the impact of covid-19 related lockdowns on the economy. But signs suggest that the economic downturn may have bottomed out, and foreign institutional investors have already started placing bets on the future prospectus of Indian economy.

The Indian economy contracted by 23.9% YOY in Q1 2020-the largest GDP contraction recorded in a quarter. The industrial gross value added fell by 22.8% in q1 2020. Almost all sectors except for the agriculture, forestry and fishing sector, have been hit hard because of the nationwide lockdown. the

manufacturing and construction sectors shrunk by 39.35 and 50.3%, respectively while the overall services sector, the key driver of the Indian economy, contracted by 20.6%.

However, there are indications that the worst is probably over. As the economy gets unlocked, manufacturing and industrial activates are gradually resuming and the lockdown induced pent-up demand is also aiding the economic rebound. India's PMI recovered from 27.4 in April 2020 to 558 in october2020

The Indian economy has started to recover from the pandemic-induced slowdown on the back of various government initiatives and is expected to carry this momentum into the short- term timeframe.

Government initiatives

As the economy went into a free-fall, the government was quick to introduce a stimulus package, atmanirbhar bharat abhiyan approximately worth RS. 20 trillion to jumpstart the economy. In addition, it took fresh measures to improve infrastructure, regulations and job opportunities that will likely aid in sustained economy recovery and rebuilding.

The atmanirbhar bharat abhiyan aims to make the country self- reliant with focus on local manufactures and services provides. The five pillars of this programmer are economy, infrastructure, technology- driven system, demography and demand. It emphasis on enhancing import substitution, reviving demand and promoting export-oriented industrialist ion as the key drivers of Indies future economic growth. Banking, businesses & MSMEs and agriculture are some of the key beneficiaries of this initiatives with 24.4% 17.12%, and 16.3% allocations, respectively.

Healthcare needs to remain the top priority to achieve the economy sustainability of India .the scheme aim to cover 500 million beneficiaries, primarily to poorest and provide coverage of approximately RS. 500,000 per family, per year.

Also, building resilient and sustainable infrastructure would help increase the production of capital goods, provide employment and revive private sector confidence. Investment in infract could be a way to achieve this objective. The rest. 111 trillion national infrastructure pipeline built on infrastructure vision 2025 was announced in December 2019

The make in India initiative was launched by the government in 2014 to encourage international firm to select India as their manufacturing center and galvanize he economy by investment in manufacturing and services. The initiative aimed to increase the manufacturing sector contribution to the gdp to 25% by 2025 from ~16-17% at present. With numerous international companies looking to shift their manufacturing base from china due to intensifying Sino-us trade friction, India is vying to occupy a major share of the supply chain shift. In March 2020, the government announced incentive door niche electronics manufacturers that make them eligible for a payment of 4-6% of their incremental sales over the next five year. As a result, about two dozen companies such as Samsung, falcon and waitron crop, have pledged \$ 1.5 billion worth investment to set up mobile phone factories in the country. The government has approved a production linked incentive scheme with an expenditure of rs. 2 trillion for 10 sectors, including electronics and technology products automobile and auto companies pharmaceutical drugs, telecom and networking products textile products and food products.

A sound and resilient banking and financial sector is the key to the economic prosperity of India. The government is consolidating the public sector bank, which are the key players in the Indian market, to increase efficiency and accountability. The npa crisis that has been plaguing the posts in India- is also being addressed with the government looking to set recovery target for the same.

Investments

The Indian economy operates on a delicate balance of state intervention and free market the foreign direct investment policy more investor friendly and removed the policy bottlenecks that have been hindering investment inflows into India. Fids in India have increased by ~16% yoy to us\$#27.1 billion from April 2020 to august 2020.

Fid equity inflows in India stood at us\$ 49.97 billion in 2019-20, with service sector attracting the highest fid equity inflow of us\$ 7.85 billion, followed by computer software and hardware at us\$ 7.67 billion, telecommunications sector at us\$ 4.44 million and trading at us\$ 4.57 billion.

Foreign portfolio investors – (FPI-FII) have been one of the biggest drivers for Indies financial markets: investment rs. 12.9 trillion In India between 2020 and 2021, at a time when most Asian markets are suffering from net withdrawal. This pony's to a high investor's confidence in the long-term prospects of Indian markets.

India's population is among the youngest in the world. By 2022, the youngest in the world. By 2022, the median age in India will be 28 years; in comparison, it will be 37 in china and the us and 45 in western europe. India's working than its non-working age population. Thus, India currently enjoys a demographic dividend, which is said to have commenced in 2055. India is also the second- most population county in the world with ~ 1.3 billion citizens. However, for India to reap the economic benefits of a vast and burgeoning working population and develop into an economic superpower, it will have to ensure to cheat a high number of skilled jobs.

Starting that India needs many things to be right for its recovery to continue, S&P said the country needs to quickly and thoroughly vaccinate most of its 1.4 billion people.S&P global ratings on Tuesday said Indian economy is on track for a recovery in the next fiscal year beginning April 1, as consistent good performance of the farm sector flattening COVID-19 infection curve, and a pickup in government spending are all supporting the economy. Starting that India needs many things to be right for its recovery to continue, S&P said the country needs to quickly and thoroughly vaccinate most of its 1.4 billion people.

"The emergences of yet more contagious COVID-19 variants with thaw potential to evade vaccine-derived immunity present a major risk to this recovery. As does the possibility of early withdrawal of global fiscal stimulus," S&P SAID IN a REPORT TITLED 'Cross-sector outlook: Indies escape from coved'.

It is said that budget for fiscal 2021-22, will also support the recovery, with higher than expected expenditures. India's improving growth prospects are critical to its ability to sustain the higher deficits associated with its more aggressive fiscal stance.

The economy still faces important risks as it transitions from stabilization to recovery. We estimate that India faces a permanent loss of output versus its pre-pandemic path, suggesting a long-term production deficit equivalent to about 10 % of GDP.

The Indian economy is on track for a recovery in fiscal 2022, bolstering corporate earnings and demand for utilities. The recovery's pace and scale determines the sustainability of government's higher fiscal deficit and debt stock consistently good agriculture performance, a flattening of the covid-19 infection curve, and a pickup in government spending are all supporting the economy.

The US-based rating agency said a sustained earnings rebound is key for ratings to stabilize as roughly one quarter of ratings are still on negative outlook. On the banking front in India, it estimates the system weak loans ratio at 12% of gross loans and credit cost to remain elevated at 2.2- 2.7 %

Economic recovery post pandemic is a global crisis that has hit the world on multiple fronts. As a result, Indies economy has taken a massive hit. There has been a sharp contraction in economic activities in 2020.the economy is believed to resume to positive growth this year. Economic recovery post – pandemic is an important topic hole over the world.

The Indian economy was one of its worst ever phases even before the covid-19 pandemic. Gdp growth fell continuously for eight quarters .GDP was 8.2% in March 2018 and had fallen to 3.1% in March 2020.private consumption and investment had collapsed even before the pandemic. Nominal GDP growth in 2019-2020 fell to just 7.2%, the lowest since 1975-76.as per the data from the controller general of accounts, gross tax revenue collections were 81.6% of the budget estimates in 2019-20, which is the lowest since 2000-01.

In the wake of the pandemic with rampant job lessees and surging covid-19 case, the Indian economy was facing a recession in September 2020. The economy recorded the largest GDP contraction 23.9% for a financial year quarter in the first quarter of 2020. The manufacturing and construction sectors shuck by 39.3% and 50.3% respectively, while the overall services sector by 20.6%. As the economy gets unlocked, it has started to recover from the pandemic- induced slowdown on the back of various government initiatives and is expected to carry on this momentum.

Financial market surges the base index jumped 91 per cent from a record low of 25881 in over 10 months.

GST collection

The GST collection was RS 1.15 lakh core in December 2020.the collection was the highest since the GST implementation

The fiscal transfers by the Indian government to household during the lockdown in the forms of mgneega and pm-kinas impacted consumer sentiments in rural areas. Consumer pyramids household survey, CMIE reports that the consumer sentiments in household with an annual incomeof over RS10 lakh were the least affected as of march 2021.

K-shaped recovery

Indies economy is expected to have a k- shaped recovery. The k-shaped recovery was most evident in the September 2020 quarter. Indies GDP is expected to grow by 12.5% in the fiscal year starting from april1, 2021.the increased inequality will hit the consumption and growth of the economy.

Government initiatives including fiscal and social measures have worked to the advantage of the economy in combating the slowdown. The covid-19 pandemic ha invariably changed the economies sentiments and functioning in India which is expected to have some long-term effects.

Father economic recovery and steps taken by the reserve bank of India and the Indian government to cushion the effect of the economic crisis have helped ease the stress on bank balance sheets.
